By visiting any Packform Sites or by participating in any of the interactive activities offered on any Packform Site, you agree to be bound by these Terms of Use. Please note that we may, in our sole discretion, modify these Terms of Use without notice to you. Therefore, please continue to review these Terms of Use when using any of the Packform Sites. By continuing to access and use any Packform Site after the Terms of Use have been modified, you will be deemed to have agreed to such modifications.

THESE TERMS OF USE, THE [PRIVACY POLICY](#), AND ALL OTHER DOCUMENTS REFERENCED HEREIN GOVERN THE RELATIONSHIP BETWEEN YOU, THE USER OF THE PACKFORM SITES ("YOU" OR "YOUR"), AND PACKFORM WITH RESPECT TO YOUR USE OF THE PACKFORM SITES.
